

Protection of Personal Information

“Visitor (Internet)” Disclosure Text

Pursuant to the Law on the Protection of Personal Information No 6698, **ASAŞ Alüminyum Sanayi ve Ticaret A.Ş.** (Asaş A.Ş.) is defined as the **data controller** since it processes personal data about you. According to Article 10 of the law titled “Disclosure Liability”, data controllers are liable to inform real persons whose data they process about certain issues.

This text has been prepared by **Asaş A.Ş.** in order to be both transparent and accountable for compliance with legislations.

Relevant Person

You are defined as the *relevant person* as the person defined as **Visitor (Internet)** by us since you visit the **Asaş A.Ş.** web site.

Data Controller

Regarding the personal data about you, **Asaş A.Ş.** is the data controller as it determines the aims and methods of processing personal data and is responsible for the establishment and management of data registration system.

Processing of Your Personal Data, Aims and Legal Reasons of Processing

For the purpose of creating and tracking visitor records, since it is explicitly put forward in the Responsibility of Hosting Provider (Article 4) in the Law on Regulation of Publications Made in the Internet Environment and Struggle Against Crimes Committed Through These Publications, pursuant to KVKK Article 5/2a:

Time of Connection, Time of End of Connection, IP Address, Used IP Protocol and Amount of Transferred Data;

Due to our legitimate interests which meet the conditions, pursuant to KVKK Article 5/2f:

Visited Page;

For the purposes of conducting contact activities and managing requests and complaints when you fill in the contact form on the contact page, pursuant to your express consent (KVKK Article 5/1):

Name, Surname, Phone Number and E-mail Address.

All of the above personal data is processed by us.

Method of Obtaining Your Personal Data

Your personal data is obtained on the Internet environment using automatic methods.

Your Rights About Your Personal Data

Relevant persons must communicate their rights about personal data to the data controller firstly. According to Article 14 of law, no direct complaints can be made to the Council of Protection of Personal Data.

Pursuant to the law and regarding your personal data, you can use your rights to:

a) Learn if personal data is processed,

- b) Request information if your personal data is processed,
- c) Learn the purpose of processing your personal data and if such data is used according to its purpose,
- d) Learn about the third people to whom your personal data is transferred to locally or abroad,
- e) Ask for correction if your personal data is processed incompletely or inaccurately,
- f) Request your personal data to be deleted or destroyed if the reasons required for processing have been eliminated,
- g) Ask for notification of the processes performed pursuant to sub-paragraph (d) and (e) to the third persons to whom your personal data is transferred,
- h) Object when a result against you, obtained through the analysis of your processed data, is exclusively by means of automatic systems,
- i) Request for compensation if you suffer damages due to illegal processing of your personal data

Method of Application
